

Proposed Right to Addiction Recovery (Scotland) Bill

Introduction

A proposal for a Bill to enable people addicted to drugs and/or alcohol to access the necessary addiction treatment they require.

The consultation runs from 7 October 2021 to 12 January 2022.

Working with people with problematic substance use, I have learned how people hoping and seeking assistance with their addictions can and often believe that help will not happen for them. It is commonly said that people will not receive assistance for their addictions until their circumstances are so severely dire, that the path to recovery seems an almost impossible task. The addiction itself seems to be not

sufficient to be considered "suitable" for assistance. The reason for this may be the limit resources available at a given time and location, but for the person in the grips of addiction seeking a way out, it reads as a measure of their value to their society.

Legislation in regards to the right to necessary recovery treatments allows for a greater understanding that the systems in place currently would need to be strengthened in their abilities to ensure treatment is accessible for all that demand it. Funding structures need to be considered when enforcing a cap-less service. Legislation will ensure that the services needed to ensure that treatment is available to all that need and want it are held to scrutiny, and i believe this process will lead to an increase in people receiving better treatments.

The ability for a person to fully engage with their treatment, understand the options available to them and are given the opportunity to enforce choice and will strengthens the potential effectiveness of the treatment process. Ensuring a fully informed and aware service user is making a free and unpressured decision, with the right to alter this decision should they feel the need to, is preferable in encouraging a more connected and participatory process that is directed by the service user with support where required/desired.
