# Proposed Right to Addiction Recovery (Scotland) Bill

#### Introduction

A proposal for a Bill to enable people addicted to drugs and/or alcohol to access the necessary addiction treatment they require.

The consultation runs from 7 October 2021 to 12 January 2022.

I welcome the right to recovery consultation on a proposed bill. People in Scotland who have a drug or alcohol addiction should be able to access person-centred support and treatment, including a full range of harm reduction and recovery services. Drug and alcohol-related deaths in Scotland remain very high. Drug

and alcohol misuse is a public health emergency in Scotland. Legislation alone will not address these challenges, however, it will establish legal rights for individuals and provide scope to place duties on health boards, ministers and other relevant bodies.

Q2. Do you think legislation is required, or are there other ways in which the proposed Bill's aims could be achieved more effectively? Please explain the reasons for your response.

Yes. I believe the right to recovery should be enshrined in law. Existing and previous policies and strategies have not been effective. Legislation will help to speed up system change and a truly rights-based approach. Work that the Scottish Government is undertaking to tackle stigma and embed a public health approach is very welcome and necessary, however, this does not address how difficult it is to navigate services. In many parts of the country, including in my own region, it is almost impossible for people to access residential rehabilitation. Not everyone is ready for treatment and recovery, and individual needs should be respected. The bill could also ensure people can access their rights in relation to harm reduction services.

There needs to be a whole system approach involving all relevant stakeholders and services. This is a view held by the Royal College of Physicians of Edinburgh and is a good guiding principle for the development of the proposed bill. Ultimately, the Scottish Government should be accountable. Good reporting will improve transparency.

A more transparent assessment of people's experiences of addiction services is needed. This will improve accountability. A specific complaints procedure that is centred on the needs of people who misuse alcohol and/or drugs and their families would be a positive development. This should be trauma-informed.

Everyone's situation is different, therefore, a person-centred approach is essential. People should be fully informed of the range of services and treatments that are available to them, whether on a short or long-term basis. This should take into account family circumstances, including caring responsibilities and other health or social care needs.

The refusal of treatment leads to people feeling abandoned, worthless and undeserving. Guaranteeing rights for people who want treatment for drug and alcohol addiction will signal how seriously Scotland takes this public health issue.

Service must be fully funded. In 2021, the First Minister admitted that the Scottish Government had 'taken its eye off the ball' in relation to Scotland's drug deaths crisis. The underfunding of services results in avoidable deaths. This must not be allowed to keep happening.

There could be some increase in costs in initial years and some reduction in subsequent years. The Scottish Government has allocated £50 million annual spending on tackling drug deaths for the next five years. The costs arising from a 'Rights to Recovery Bill' could be supported from that budget. There is an opportunity to achieve savings through preventative spending. The Bill would encourage earlier intervention and people getting the right treatment at the right time, reducing pressure on housing, prisons,
