

Proposed Right to Addiction Recovery (Scotland) Bill

Introduction

A proposal for a Bill to enable people addicted to drugs and/or alcohol to access the necessary addiction treatment they require.

The consultation runs from 7 October 2021 to 12 January 2022.

All those wishing to respond to the consultation are strongly encouraged to enter their responses electronically through this survey. This makes collation of responses much simpler and quicker. The MAT Standards should already have ensured a rights based approach had been implemented within treatments services across the country which leads to my concerns around this bill. What's going to change with The Right to Recovery Bill? I believe the 2 of the main challenges are focused on culture within statutory drug and alcohol services - lack of quality support/supervision, care planning, excessive caseloads and stigmatising attitudes from some staff still exist. There is also no accountability for statutory services. My experience from working in third sector services is that these services are not monitored, audited, reviewed regularly for minimal funding and often 2-3 year funding cycles which means staff and organisation time is spent on retender processes and evidencing work.
